

Sponsorship Change Request Form

To protect the integrity of all marketing organizations and safeguard the hard work of all **PrimeMyBody** Affiliates, **PrimeMyBody** strongly discourages changes in sponsorship. Maintaining the integrity of sponsorship is critical for the success of every Affiliate and marketing organization. Accordingly, the transfer of a **PrimeMyBody** business from one sponsor to another is rarely permitted. A change request must be submitted and completed prior to the changing Affiliate Sponsoring an Affiliate of their own. If a request for change in sponsorship is made within three (3) days of enrollment, then **PrimeMyBody** will waive the processing fee. All requests for change of sponsorship must be submitted in writing to the support@primemybody.com, and must include the reason for the change in sponsorship. Sponsor changes are subject to **PrimeMyBody's** Corporate approval, which may be withheld at any time. The Affiliate seeking to change sponsors must submit a properly completed and fully executed Sponsor Change Request Form, which includes the written approval of their sponsor. **PrimeMyBody** Affiliates need to allow up to seven (7) days for the change in sponsorship. The **PrimeMyBody** Affiliate who requests the change must submit a fee of \$50.00 for administrative charges and data processing, for any request made three (3) days after enrollment. **PrimeMyBody** reserves the sole and exclusive right to determine the final disposition of the downline organization. Resolving conflicts over the proper placement of a downline that has developed under an organization that has improperly switched sponsors is often extremely difficult. Therefore, **Affiliates waive any and all claims against PrimeMyBody that relate to or arise from PrimeMyBody's decision.**
